CONTENT:

The class that I observed was a Beginning Tap dance class that was meeting in person in one of the Fresh Foods dance studios. This class is for Musical Theatre majors who do not already have a strong background in tap dance. Tap dance is a challenging style for students, as it requires the ability to develop whole body coordination (especially legs and feet), along with an understanding of the musical rhythms inherent in this style of dance. Stacy was able to deliver the class material in a way that addresses each of these different elements of tap dance.

Stacy seems knowledgeable and confident in teaching tap dance technique. The class began with some simple warmups for feet and ankles that was appropriate for the students in this class. This allowed the dancers to focus on the rhythm and coordination. She then paused after the initial warmup to give a few corrections. Stacy then introduced some new material, gave the students a few minutes to practice and incorporate the material, then had them perform the new steps in small groups (3 at a time), then as individuals. She gave each of them feedback.

After repeating this process with additional new material, Stacy moved to a choreographic sequence that the class has previously started working on. This longer movement phrase gave the students an opportunity to incorporate the elements of technique, rhythmic accuracy and musicality as preparation for "performing" tap choreography.

After each sequence, Stacy gave feedback that was stern but also encouraging.
