

# How to find your 1098-T on ZotPortal

1. Log into ZotPortal
2. Go to Students (blue menu) and click "Finances" yellow menu"
  - a. Green arrow
3. Scroll down to "IRS Form 1098-T Access" and make sure you have consented to an electronic form
4. Select Tax Year and click "Search" in the gray box
  - a. Green arrow
5. A hyperlink will appear next to the gray box that leads to your 1098-T

3. Answer any security questions when prompted
