## Background and Definitions

On April 5, 2022, the residents of Lund Family Hall, the greater UP community, and the Pastoral Resident for Lund Family Hall, Father Dan Parrish, came together in a town hall format to discuss recent allegations of the misconduct and homophobic actions that Father Dan was demonstrating through social media, emails, and other outlets. It became increasingly clear that pride flags in dorm halls that represent inclusivity and safety for the LGBTQIA+ community of the student body should be required by residence life. It also became clear the need for a definition of what the pride flag means and represents for the UP student community. This resolution is meant to demonstrate the Associated Students of the University of Portland's (ASUP) (1) support for the requirement of flags in residence halls, (2) the need for additional diversity training for Residence Hall Staff which includes Hall directors, Assistant Hall Directors, and Pastoral Residents, and (3) require Campus Ministry to provide anti-bias training for all members of the Holy Cross who are a part of the University of Portland. Definitions:

**Pride Flag:** A rainbow flag that demonstrates inclusivity and safety for the LGBTQIA+ community.

**Diversity Training:** A program designed to facilitate positive intergroup interaction, reduce prejudice and discrimination, and generally teach individuals who are different from others how to work together effectively.

Therefore, be it further resolved, ASUP endorses the idea that Residence Life mandates all residence halls on campus to include a Pride Flag within the hall,

Therefore, be it further resolved, ASUP endorses the idea for Residence Life and Campus Ministry that greater diversity training is needed for hall staff, in order to serve as distinguished support systems for the student body,

Therefore, be it further resolved, ASUP endorses the idea that Campus Ministry requires all members of the Holy Cross that are also part of the UP Community to undergo anti-bias training upon their arrival at the University.
